2. Foreign aircraft that belong to special categories

In order for foreign ACFT that belong to special categories (i.e. ACFT that do not, or only partially (or temporarily not), meet the airworthiness requirements of ICAO Annex 8) to be flown into and operated in Switzerland, a special permit is required for the use of Swiss airspace. Applications for a special permit must be submitted so that they are received by FOCA not later than two full working days prior to the intended FLT.

Applications submitted by e-mail must be accompanied by the following documentation in Ge, Fr, It or En:

- Airworthiness certificate, including any imposed restrictions, or
- FLT APV, including any special requirements
- Noise certificate (if applicable)
- REG certificate
- MAINT record incl. annual inspection
- Third party liability insurance policy

Exceptions:

A special permit for entry into Switzerland or for the use of Swiss airspace is **not** required for ACFT that have been registered in the European Economic Area with a permit to fly containing the following wording: "This permit to fly has been issued in accordance with Regulation (EC) 216/2008, article 5, paragraph 4a, or Regulation (EU) 2018/1139, article 18 paragraph 2b and certifies that the ACFT can be safely operated within the scope of the purposes cited below and under the stated conditions; **it is valid in all member states.**"

Furthermore, in application of ECAC Recommendation INT S/11-1 dated JUN 1980, no APV is required for issuing a permit for entry into Switzerland for home-built ACFT that have been registered in ECAC States. However, this principle does not automatically apply to all types of operation. For example, in Switzerland foreign home-built ACFT are not permitted to carry out FLT's in accordance with VFR Night and IFR unless they meet the respective Swiss requirements.

Likewise, according to the ECAC Recommendation ECAC/35-1 dated 18 May 2016, aircraft in the category "antique/historical" that are registered in an ECAC state are exempt from the authorization requirement for the use of Swiss airspace. Please note, that only originally factory-manufactured aircraft, previously holding an ICAO compliant Certificate of Airworthiness are excluded from the special permit requirements.
