Customs procedures applicable to goods carried by ACFT are based on the following legal provisions:

- Ordonnance douanière du 7 juillet 1950 sur la navigation aérienne, chapitre V.

**3. Importation and transshipment of animals**

The importation and transshipment of animals are subject to certain control procedures (see: "Loi fédérale sur les épizooties", 1er juillet 1966 and related provisions, the Washington convention on endangered species, 03 MAR 1973 and the "Ordonnance sur la conservation des espèces", 16 juin 1975).

The International Air Transport Association (IATA) Live Animals Regulation on labelling and CONST of containers is compulsory.

**4. Importation, transshipment and exportation of war material**

The importation, transshipment and exportation of war material are subject to a special AUTH to be granted by the Direction de l'administration militaire fédérale, CH-3003 Berne.

## **5. Export and transit of "dual-use" goods (MIL and CIV application)**

Certain "dual-use" goods can not be exported without prior written APV by the Federal Office of Foreign Economic Affairs, Import and Export Division, Section Industrial Products, CH-3003 Berne. For the transit of these goods, a legal AUTH of the country of origin has to be produced.

## **6. Importation and exportation of drugs**

The importation and exportation of drugs are subject to an AUTH to be granted by the Office fédéral de la santé publique, section pharmaceutique, CH-3012 Berne.

## **7. Safe transport of dangerous goods by air**

The importation, transshipment and exportation of dangerous goods are subject to an AUTH to be granted by the:

Article 16 of the Air Transport Ordinance of 17 AUG 2005 (SR 748.411):

1. For the transport of dangerous goods by air on national and international FLT's, the standards contained in ICAO Annex 18 and the corresponding technical instructions are directly applicable\*, subject to any differences notified in accordance with article 38 of the Convention on International Civil Aviation of 7 DEC 1944.
2. This article also applies to transportations not conducted commercially or against payment.
3. The FOCA may, under special circumstances, AUTH exemptions for certain types of transportations in individual cases and, if applicable, for a limited period. In the event of an international FLT, the applicant must obtain the consent of the States of Overflight.
4. The competent authority for the APV of package designs and the sending of radioactive materials as defined in the standards mentioned in paragraph 1, is the:

## **8. Carriage of human remains**

### **8.1 Worldwide arrangement**

On a worldwide basis, the carriage of human remains is governed by the "Arrangement international concernant le transport des corps" concluded at Berlin on 10 FEB 1937.

Contracting parties: Austria, Belgium, Czechia, Egypt, France, Germany, Italy, Mexico, Republic of Zaire, Romania, Slovakia, Switzerland and Turkey.

Such shipments coming from non-contracting States must be accompanied by a "laissez-passer" issued by a Swiss diplomatic or consular representation.

### **8.2 European agreement**

On a European basis, the carriage of human remains is governed by the "Agreement on the transfer of corpses" concluded at Strassburg on 26 OCT 1973 and signed by Switzerland on 17 DEC 1979.
